SUBJECT: Rescission of Coat of Arms and Distinctive Insignia for the
161st Armored Infantry Battalion, California National Guard

1. The coat of arms and distinctive insignia for the 161st Armored
Infantry Battalion, California National Guard, rescinded this date, were:

a. Originally approved for the 161st Armored Infantry
Battalion, California National Guard, by letter QMGRH 424.2 & 421.4
161st Arm'd Inf Bn, Cal NG, Office of The Quartermaster General, 14 March
1955.

b. Amended to correct the wording in the blazonry of the
shield by letter QMGRH 424.2 & 421.4 - 161st Arm'd Inf Bn, Calif NG,
Office of The Quartermaster General, 1 September 1955.

2. Authority for Action: Letter, NG-AROTO 325.4 - California,
Office of the National Guard Bureau, subject: Reorganization of the
Army National Guard 1958-60, dated 23 April 1959.

3. Other Applicable Data: The 161st Armored Infantry Battalion
was deleted from the Troop Allotment to the State of California,
effective 1 July 1959, by authority of the above cited National Guard
Bureau letter. By the same authority the 161st Armored Infantry
Battalion was reorganized and redesignated the 3d Armored Infantry
Battalion of the 160th Infantry, a California National Guard Regiment
organized under the Combat Arms Regimental System.

TO: Chief, National Guard Bureau

1. The coat of arms for the 161st Armored Infantry Battalion, California National Guard, is approved. The blazonry and description are as follows:

BLAZONRY

SHIELD: Argent, a carabao azure; on a canton of the last a chevron and a fleur-de-lis of the first; all within a bordure of the second.

CREST: That for the regiments and separate battalions of the California National Guard: On a wreath of the colors (argent and azure) the setting sun behind a grizzly bear passant on a grassy field all proper.

MOTTO: Mobilitas Victoria (Mobility is Victory).

DESCRIPTION

The shield of the coat of arms for the 224th Infantry Regiment, differenced by a blue border, is used to indicate the descent of the 161st Armored Infantry Battalion from the 3rd Battalion of that organization.

In the designing of the coat of arms of the 224th Infantry Regiment, the basic design of the shield of the coat of arms of the 185th Infantry Regiment, in reverse colors with the carabao head added to symbolize service in the Philippine Islands during World War II, was used to indicate descent from the latter organization.

The chevron and fleur-de-lis on the canton indicate World War I service of the units from which the 185th Infantry Regiment descended. The colors blue and white are used for Infantry.
